TOWNSHIP RESIDENTS

- Bob Hyde, 441 Smokey Corners Road Mr. Hyde stated that the road in front of his property was raised approximately 16" after the paving of a portion of Smokey Corners Road was completed by HRI. Mr. Hyde expressed his concern that storm water that use to run over the road will now divert onto his property. Chairman Hamm requested that Road Foreman Scott Paulhamus contact Tom Lyons from Municipal Solutions to review the situation and make recommendations to permanently fix any issues.
- Fred Wesley, 1286 Factory Road Mr. Wesley questioned the paving at the intersection of State Route 973 East and Factory Road. Chairman Hamm informed Mr. Wesley that this was required by PennDOT to keep the water flowing into the ditch next to the road.

ROAD FOREMAN REPORT – Scott Paulhamus

- Mr. Paulhamus stated that there is approximately 7 ½ miles of road that need lines painted this year. The approximate cost will be \$8,000. A motion was made to approve this cost.

- Mr. Paulhamus stated that there is a sink hole on Old Route 15 that needs to be filled in due to erosion of the pavement. Chairman Hamm requested that Tom Lyons from Municipal Solutions review the project and the bid language prior to putting the project out for bid.

OLD BUSINESS

• Chairman Hamm provided an update on the Mutchler Park Playground project. The equipment has been delivered and the plans have also been received. The playground equipment will be installed as soon as possible, weather permitting.

- Public Hearing: Joint Pollutant Reduction (PRP) Plan Anne Anderson from Brinjac Engineering presented an overview of the PRP Plan. She asked for any comments or questions from residents in attendance and received no comments or questions. Ms. Anderson reminded residents and the Board of Supervisors that comments would be accepted until August 31, 2018.
- Resolution 08.14.18.01 (Adopting Permit Fee Schedule) A recommendation was made by Zoning Permit Officer Don Robinson regarding fees for permits in the Township. This resolution was tabled until the September meeting.
- Gas Industry Update Seneca Resources continue to work on well pads in the area. NFG is reviewing Brucklacher Road for repairs.

- Attorney Drier briefed the Board of Supervisors on a legal decision recently that involved Inflection Energy and Fairfield Township. The Pennsylvania Supreme Court ruled in the case.
- Attorney Drier stated that the Smokey Corners Project is moving forward with agreements being signed and an LLC being worked on.
