- Ken Snyder, 2405 SR 973 East Mrs. Snyder inquired as to whether the Township would consider selling the strip of land to the West of the drive into the Township Maintenance area.
- Jeff Yeager, 324 Sawmill Road Mr. Yeager stated that water is laying on the east side of Sawmill Road. Scott Paulhamus will clean out the ditch and grade the berm to make this area lower than the road.
- Mr. & Mrs. Don Leathers, 386 Factory Road Inflections representatives were in touch with Mr. and Mrs. Leathers and stated they will be doing a sound study.

POLICE REPORT – Officer Mike Engel

- December 2022 –33 Incidents; YTD –543 Incidents
- Officer Engel noted that the police department has a new name, "Lycoming Regional Police Department". This change reflects the regionalization of the police department.

FIRE COMPANY - Don Confer, President

- The new engine will be put into service soon.

ROAD FOREMAN REPORT – Scott Paulhamus

- Mr. Paulhamus stated that new generator has been hooked up.

NEW BUSINESS

- Purchase of AED Machines (Automated External Defibrillator) Supervisor Heller stated that the Board would like to purchase 2 AED Machines. The total cost of the two machines will be \$3897.50. One machine will be given to Hepburn Lycoming Little League and there will be a requirement that someone will have to be certified in the use of the machine. COVID 19 ARPA Funds will be used for the purchase of the machines. A motion was made to move forward with this purchase.

- Permitted Recreational Use of Township Property A group has contacted the Township regarding their interest in using 16 acres of Township property for hunting and would also like to include 5 acres across the road. The 5 acres is within a safety zone, so this would not be permitted. After discussion, the Board decided not to allow this use.
- SEO Officer The Board noted that Jami Nolan (the Township current SEO officer) has submitted a proposed contract to the Township for 2023. After discussion, it was decided not to continue using Mr. Nolan. The Township will contract with Old Lycoming Township's Sewage Enforcement Officers: Mike McClain, SEO, and John Giacomi, Alternate.
- Fuel Tank Maintenance The purchase of a new 1000-gallon fuel tank for diesel fuel was presented. This tank will replace the 500-gallon tank currently in use. Professional Petroleum quoted \$6,625.35 for the new tank. A motion was made to purchase the 1000-gallon tank.
