#### **OLD BUSINESS**

- Police Regionalization Update The new police regionalization agreement has been passed by Old Lycoming Township 2-1. The new police department will be called *Lycoming Regional Police Department*. Hepburn Township will be notified of the cost for service in about 30 days.
- Compressor Noise Hensler Well Pad Double Conex has been placed at the well pad. The noise level has dropped and is definitely better. Greg Saunders from Inflection Energy will take readings and will continue to work on reducing noise.

#### **NEW BUSINESS**

- Removal of the Firearm Ordinance 6-3 This removal has been presented as it goes against the second amendment. This ordinance will be advertised for approval at the November 8 meeting.
- Short Term Rental Ordinance This ordinance will be advertised for approval at the November 8 meeting.
- Solar Ordinance This ordinance refers to solar farms, not residential solar panels and will require a conditional use hearing. This ordinance will be advertised for approval at the November 8 meeting.
- A motion was made to make a donation to the Hepburn Volunteer Fire Department for a used fire truck with 1000-gallon tank. The amount of the donation will be \$40,000 and will be distributed from the Covid 19 ARPA funds.

- Purchase of a generator for the Fire Department is being considered as the fire hall is a community shelter. The generator must be an LP generator.
